Scheduled June payment date: The payment for the February-May period of 2023 will be deposited on June 9.

● **Child allowance (for person whose income is below the income limit)**

Age category	Payment amount (monthly)
0 to under age 3 (flat rate)	15,000 yen
From age 3 until completion of elementary school education (1st or 2nd child)	10,000 yen
From age 3 until completion of elementary school education (3rd child and later children)	15,000 yen
Junior high school student	10,000 yen

● **Special Allowance**

(for person whose income meets or exceeds the minimum income limit but is below the maximum income limit)
Flat rate of 5,000 yen per month

【Remember to Submit a Status of Residence Application for Your Newborn Baby!】

If a baby has been born into your household in Japan and either of the following applies, you must submit an application to acquire status of residence for your newborn at the Tokyo Regional Immigration Bureau within 30 days of his or her birth date.

- Your baby's nationality is not Japanese
- Your baby will stay in Japan for 60 or more days after birth

【Ota City Issues Tax (Tax Exemption) Certificates and Tax Payment Certificates】

Ota City will issue certificates of taxation (or tax exemption) and payment of inhabitant tax (special city inhabitant tax and metropolitan inhabitant tax) for the new fiscal year (FY2023) upon request. You are eligible to receive a certificate (as proof of income during FY2022) if you were a registered resident of Ota City on January 1, 2023, and filed a tax return.

【The following must be presented to receive a certificate】

- When visiting the service counter in person
Personal identification (e.g., residence card, etc.)
- When someone representing you visits the service counter
 - Letter of Proxy (委任状) (A Japanese translation will also be required if the letter is written in a language other than Japanese.)
 - Personal identification of the person representing you
- * The Letter of Proxy form can be printed out from the Ota City website.

【Special Exhibition Commemorating the 200th Anniversary of Katsu Kaishu's Birth】

~ Kaishu and His Family at the End of the Shogunate: The People Who Acted in Kaishu's Absence ~

Kaishu Katsu devoted himself to serving Japan at a time when the country was on the brink of leaving the samurai era and entering a new age. This exhibition sheds light on the hidden activities of Kaishu's family and followers while he was away carrying out his duties. It also explores the relationships those people had with Kaishu. Featured exhibits include portraits of Kaishu's family members that were restored through a crowdfunding campaign in 2021 and a newly created interpretive video. A book explaining the exhibits is available for purchase.

Ota City Community Cycle is a bicycle sharing service that lets you pick up and return a bike at any of the service's cycle ports. Bikes can also be picked up and returned at any cycle port within fifteen cities (special wards) of Tokyo.

【About Unattended Bicycles and Their Impoundment】

Ota City asks you to obey city ordinance by not leaving your bicycle unattended in public places (i.e., roads, parks, railway station plazas, or any other place that is not a designated bicycle parking area). **Always park your bicycle in a bicycle parking area, even when only stopping for a short time.**

Certain areas in front of train stations are designated as "no bicycle parking" zones under city ordinance. The city regularly impounds bicycles that are left in those zones. Impounded bicycles are generally held at an Impounded Bicycle Storage Center for 30 days. They will be disposed of when this storage period expires. Help us create a safe community without illegally parked bicycles by following cycling rules and etiquette.
